Visitors included John Drover, Donald Gosse, Howard Smith, Dave Gosse, Tony Menchions, and Brenda Coombs. Mayor Brazil called the meeting to order at 7:01 pm and welcomed everyone to the meeting.

# Motion to Adopt Agenda

The agenda for January 16, 2019 meeting was tabled. It was moved by Councillor Jewer, seconded by Councillor Ryan, to adopt the Agenda of January 16, 2019 as presented.

# **Town Managers Report**

- 1. To the best of our knowledge there are no leaks outstanding.
- 2. Attached to my report is a request for a permit received today to construct a 28ft by 32 ft house on their property at 253-261 Back Track. Lot size is approximately 150 ft by 300 ft which is more than adequate for private well and septic system.
- 3. I need the Finance Committee to schedule a meeting to review a proposal received for banking services for the Town. In addition, I have a request from a property owner to meet with the committee to discuss payment arrangements on their account.
- 4. I have a request to rent out room 18 near the back of the upstairs portion of the Municipal Centre. This room measures 17 ft by 33 ft (561 square feet). I need the input from the Building Committee or Council on an acceptable rate that would include electricity.

- 5. Reminder to any Councillor who has not submitted their annual disclosure statement to submit it to the office at the earliest convenience.
- 6. The 2014 half tonne pickup is currently in the garage for non start issue. We have not yet been advised of the cause of the cost for repair.
- 7. All snow clearing equipment is in good working order.

## Motions Arising from Town Manager's Report

It was moved by Councillor Jewer, seconded by Councillor Ryan, to grant the permit for the new home at 253 Back Track Road in accordance to the provisions of the Town of Spaniard's Bay Development Regulations and/or all other applicable provincial and federal regulations.

The Finance Committee generally agreed to meet at 4:00 pm on January 17, 2019 to discuss banking matters for the town and to discuss payment arrangements with a resident on their account.

Councillor David Smith stated that himself and Councillor Ryan discussed the issue of renting room number 18, he stated that there are a lot of issues to consider with this, as this will create a lot of foot traffic throughout the building and could cause congestion to our parking lot at busy times. He questioned if the business owner would consider taking a room in the basement instead. Town Manager Tony Ryan stated that he had discussed this but it seems he wants to be upstairs.

It was moved by Councillor David Smith, seconded by Councillor Ryan to refer this matter to the building Committee for review and recommendation back to Council

# 2019 Budget

# 2019 Tax and Fee Rates

Deputy Mayor Stamp presented the Annual Operating Budget for 2019. All rates and fees from 2019 shall remain unchanged for the upcoming fiscal year.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, that Council adopt the following Basic Fee Structure setting tax rates and fees for service for the 2019 fiscal year.

# 2019 Annual Budget

## **Basic Fee Structure**

Minimum Charge of \$2,000.00 plus the cost of asphalt repair if required. Fee must be paid before work commences.

Carried

Connection Fees on main thoroughfares shall be priced according to each job.

# 2018 Operating Budget

Deputy Mayor Stamp summarized the operating budget for 2018 and fielded questions from Council.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to adopt the Balanced Operating Budget for 2019 with Revenues and Expenses totalling \$ 2,318,380.29.

# 5 Year Municipal Capital Works Plan

Deputy Mayor Stamp summarized the towns 5 Year Municipal Capital Works Plan. The Following are a list of items to make up the priority list for the Town's 5 year Municipal Capital Works Plan.

Items already approved and scheduled to be completed in 2019 include Paving and Road Reconstruction at Brown's Road, Lift Station Upgrade at Mint Cove adjacent the gazebo area and to install a backup generator system at the Town's Chlorination Plant. Further to this, we have applied to complete Paving and Road Reconstruction at Mint Cove Pond Road North and are awaiting approval for this project. Financing involved with these projects are already included in the 2019 Operating Budget.

Other priorities on a go forward basis include Paving and Road Reconstruction at Pondside Road, Rectory Avenue, Casey's Lane and to provide water and sewer services to the houses inside the overpass along the main road through Tilton (Paris).

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to accept the 5 year Municipal Capital Works Plan in the priority order as presented.

# Gas Tax Projects

Deputy Mayor Stamp stated that the Town has funding available under the Federal Gas Tax Program to be spent on Gas Tax Eligible Projects. The current amount available is \$260,352.72 up to March 31, 2019 which is the end of the current phase of the Gas Tax program. Subject to approval from Council, we will be submitting a Capital Investment Plan to complete the projects listed below in the order they appear up to the amount of the available funding.

- 1. Replacement of Windows at the Municipal Centre
- 2. Paving/ Resurfacing Hunt's Road.
- 3. Paving/ Resurfacing Peddle's Road.
- 4. Paving and Reconstruction Butt's Path between Seymour's Road and Whalen's Road.
- 5. Paving and Road Reconstruction at Finn's Drive and Whalefinn Drive.
- 6. Improvements to the Entrance of the Ryan's Brook Mini-Park.
- 7. Construction of New Municipal Depot behind the Municipal Centre

Council will also revisit the topic of Providing Water and Sewer along Big Pond Road including preparing estimates and trying to determine whether or not this project will qualify under the Capital Works Program.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to accept the priority list for projects under the Gas Tax Program as presented and to submit a capital investment plan in that order up to and including current available funding of \$260,352.72.

Councillor Jewer stated that there is a hydrant right before the overpass that the Fire Department has access to as well as their pumper truck, but the Town Manager can notify the resident that adding water and sewer services to that area is now in our new 5 year plan.

Councillor Ryan asked Council to decide if they thought he was in Conflict of Interest on this matter, as he owns the waterline which they could possibly need for town services.

Councillor Ryan left the meeting at 7:35 pm

Councillor David Smith stated that he believes that he is in conflict as he could gain if the owners wanted to tie into the waterline. Councillor Jewer stated that he agrees with Councillor David Smith if this was the application for the permit to build, but the applicant is just looking for recommendation to apply for the crown land.

It was moved by Councillor David Smith, seconded by Deputy Mayor Stamp that Councillor Ryan is in Conflict on this matter. Councillor David Smith voted in favor of this motion and Mayor Brazil, Deputy Mayor Stamp, Councillors Lundrigan, Jewer and Tracy Smith voted against it.
