April 29, 2019

A regular meeting of Council took place on the above date with the following members in attendance: Mayor Brazil, Deputy Mayor Stamp, Councillors Jewer, Ryan, Lundrigan, D Smith and Town Manager Tony Ryan. Councillor Tracy Smith was out sick. Visitors included Don Gosse, John Drover, Calvin Ledrew, John Churchill, Leslie Janes, Sheldon Coombs, Jackie Coombs and Andrew Robinson from the Compass. Mayor Brazil called the meeting to order at 7:04 pm and welcomed everyone to the meeting.

Motion to Adopt Agenda

The agenda for the April 1, 2019 meeting was tabled. Deputy Mayor Stamp asked to have to items added to the agenda.

Business arising from the Minutes

Councillor Jewer questioned if the updates have been complete on the lighting at the Fire Hall. Town Manager Tony Ryan stated that it is near completion. Councillor Jewer questioned if the Town Manager had any idea when the new window replacement would be started. Town Manager Tony Ryan stated that the windows have been ordered and should take about 3 weeks, so should be here any time.

Town Managers Report

Planning Committee

317 Conception Bay Highway- Shed Extension

An application was tabled at the April 1, 2019 Council Meeting to add an extension to an existing shed at 317 Conception Bay Highway. It was referred to the Planning Committee for review and recommendation back to Council.

It was moved by Councillor Ryan, seconded by Councillor D Smith, to recommend approval for a shed extension in accordance to the provisions of the Town of Spaniard's Bay Development Regulations and/or all other applicable provincial and federal regulations.

19 Back Cove Road North - New Garage

An application was tabled at the April 1, 2019 Council Meeting to build a new garage at 19 Back Cove Road North. It was referred to the Planning Committee for review and recommendation back to Council.

Tourism Committee

Deputy Mayor Stamp stated the Tourism Committee are in the process of opening in an office in our building. They are looking at making their entrance more welcoming for tourists. They are looking at putting in some flower pots, signs and a flag. Currently there is

a large rental sign on the building. They are asking to have the sign moved to the other side of the building.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to check into getting a quote for a more suitable sign for the front of the parking lot to advertise the Town and its tenants.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to defer the request to have the rental sign moved until the town addresses the new signage and design for the front of the building.

Carried

Town Manager Tony Ryan stated that he would like to make a comment on the front of the building. There is nothing wrong with the structure of the building, its just the board on the front of the building is rotted and needs to be replaced.

Heritage Committee

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to accept the minutes of the Heritage Committee meeting on April 18, 2019.

Marina Committee

Councillor David Smith declared a Conflict of Interest on this item in accordance with Section 207(1)(c) of the Municipalities Act as his family owns property nearby. He left the meeting at 7:24 pm.

It was moved by Councillor Jewer, seconded by Deputy Mayor Stamp, to accept the request from the Marina Committee to donate the old building at the wharf to the Town of Bishop's Cove. The cost of relocating will be at the expense of the Town of Bishop's Cove and it can only be moved once the Wharf Contractor is ready.

Public Works Committee

Resident of Pondside Road- Sewer Issues

A letter was tabled at the April 1, 2019 meeting requesting the town to repair sewer line repairs on a property, as the resident stated it was due to a sewer back up when the towns lift station was down.

It was moved by Councillor Jewer, seconded by Deputy Mayor Stamp, that the town repair the elbow (cleanout) outside the Peddle property at Pondside Road. The property owner is responsible for back water valves.

Person with Delegated Authority - Anthony Ryan

Councillor Ryan asked Council to decide if he was in Conflict on the matter.

It was moved by Councillor Jewer, seconded by Councillor D Smith, that Councillor Ryan is not in conflict on this matter.

It was moved by Councillor Jewer, seconded by Deputy Mayor Stamp, that Council reaffirm that Anthony Ryan, Town Clerk/Manager is a signing officer for the Town of Spaniard's Bay since June of 2001. Mr. Ryan is the person with delegated authority to deal with all matters involving the Town of Spaniard's Bay and the Canada Revenue Agency and/or Service Canada.

Clerk 1 Position

Mayor Brazil stated that we need to advertise for a Clerk 1 Postion for part time for the office. Gloria has retired but has been filling in when needed and she is ready to fully retire, so we need someone to help cover sick days and holidays in the office.

It was moved by Councillor Jewer, seconded by Councillor Ryan to advertise this position internally until May 3 2019, and then publically after that date.

Councillor Lundrigan questioned if this position could potentially do what we discussed earlier about the recreation director position? Mayor Brazil stated that it is something we call look into in the fall, as we were not prepared to make any decisions on that position until after the summer.

It was generally agreed to set up a hiring committee for the Clerk 1 position consisting of the Mayor, Deputy Mayor, Town Manager and Councillor Lundrigan.

Council Orders

Status of Murrin Building Concerns

Deputy Mayor Stamp stated that this was put on the agenda as there are many safety concerns with the condition the building is in, and people entering the building. Since then the Town Manager has been speaking with the property owners and they are going to have the property barricaded and have someone set up to have the building removed.

House at 11-13 Crane's Road

Town Manager Tony Ryan stated that this order was sent out before Christmas and the owner had contacted that town and stated that he had a contractor set up to take care of the building but asked could we wait until the weather cleared, this was fine. Town Manager Tony Ryan stated that the weather is now fine but he was notified a couple of days ago that the property owner told the contractor to hold off on the work. This is not what was agreed.

It was moved by Councillor Ryan, seconded by Councillor D Smith, to write a follow up letter giving the property owner 28 days notice to comply or the town will take action and remove the structure at the cost of the owner.

Town Ambassador

Deputy Mayor Stamp stated that we use Mr. Gordon Parsons for special occasions playing the bag pipes. I thought it would be nice that we could officially apoint Mr. Parsons as the "Town Piper"

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, to appoint Mr. Gordon Parsons as our Town Piper and Ambassador.

Illegal Dumping

Deputy Mayor Stamp discussed the amount of illegal dumping happening within our town. She stated it is something that needs to be dealt with. A general discussion occurred regarding the cost of cleaning it up and some ideas on how the town should deal with such matters.

It was moved bu Deputy Mayor Stamp, seconded by Councillor Jewer, that every case of illegal dumping that the town receives should be reported to the RCMP and raise the topic of Illegal Dumping at the Joint Council's meeting.

Amendment of Town Plan - Gullies Road

A letter was tabled from a property owner of Gullies Road, requesting re-zoning of a piece of property he owns.

It was moved by Councillor Jewer, seconded by Councillor Ryan, to accept the request from R. Mercer to look at re-zoning at Gullies Road.

There was a general discussion regarding access to water/sewer, garbage collection and fire protection for this area.

Intersection at Seymour's Road - Crane's Road

A letter was tabled regarding the intersection at Seymour's Road - Crane's Road, the resident stated that it is a very hazardous intersection and is asking the town to do something to make it more safe.

Mayor Brazil stated that the town already met with MHA Pam Parsons regarding this intersection, and it has been sent to the Department of Transportation for review. Councillor Jewer stated to send this matter to Public Works for review and follow up with Department of Transportation and report back to Council.

It was moved by Councillor Jewer, seconded by Councillor Ryan, to send this request to the Public Works Committee for review and recommendation back to Council.
