A regular meeting of Council took place on the above date with the following members in attendance: Mayor Brazil, Deputy Mayor Stamp, Councillors T Smith, D Smith, and Lundrigan. Visitors included Howard Smith, Jackie Coombs, Sheldon Coombs, John Drover, Dave Gosse, Lewis Sheppard and Compass/Andrew Robinson. Mayor Brazil called the meeting to order at 7:03 pm and welcomed everyone to the meeting.

Motion to Adopt Agenda

The agenda for the July 22, 2019 meeting was tabled.

It was moved by Councillor David Smith, seconded by Deputy Mayor Stamp, to adopt the Agenda of July 22, 2019 as presented.

Petitions and/or Visiting Groups

Mr. Lewis Sheppard - Land at Chipman's Road

Mr. Lewis Sheppard stated that he is representing his son Terry Sheppard in the matter of services to his property on Chipman's Road. He stated that they are requesting that the Town cover the costs of extending the existing waterline to the manhole at the end of the pavement. He has stated that he has asked numerous times over the years to complete this work before the road was paved. They are now trying to sell the land and with the quote of approximately \$30,000 to complete the waterline, they are losing the potential sales. Councillor David Smith questioned if he has any documentation supporting these past requests or was it all done by word of mouth. Mr. Sheppard stated that he does have documents at home.

It was moved by Councillor David Smith, seconded by Councillor Tracy Smith, to defer this request to the Public Works Committee for further review and recommendation back to Council.

Business arising from the Minutes June 25, 2019

Deputy Mayor Stamp stated that at the June 25th, 2019 Meeting, Council referred the sale of 3 pieces of property to the Finance Committee for review and recommendation back to Council. The Finance Committee is still awaiting property assessments from the Assessment Agency and once received the Committee will bring back a recommendation.

Deputy Mayor Stamp inquired when council was going to meet in regards to the Ryan's Brook development. Mayor Brazil informed Council that Ken McDonald will be visiting Wednesday July 24, 2019 and will be viewing the Ryan's Brook area and hopefully can help us secure some funding for the project. He stated that they will need to set up a meeting in the future to further discuss.

Deputy Mayor Stamp inquired on updates for the new signage located at the Municipal Office. Councillor David Smith stated that he has not heard back from companies with any quotes. The estimated cost for a pressure treated sign is in the range of \$2500.00.

Deputy Mayor Stamp put forth a request for a design of the front of the Municipal Office. She stated that Town Manager Tony Ryan sent out a request for Council to decide on the designs presented. Once Council picks a design Silk Stevens can be instructed to go forth with submitting an estimate to complete the project.

It was moved by Councillor Tracy Smith, seconded by Councillor David Smith, to accept Option #2 and have Silk Stevens complete quote.

Call For Bids - Town Depot

Mayor Brazil stated that the Town opened a Call for Bids for repairs to the Town Depot and only one bid was received from Atlantic Enterprises in the amount of \$19,793.80 HST included.

It was moved by Deputy Mayor Stamp, seconded by Councillor Tracy Smith, to accept the bid from Atlantic Enterprises for repairs to the Town Depot in the amount of \$19,793.80 HST included.

Request to purchase piece of land owned by the Town

A letter was tabled to purchase a piece of land located on Big Pond Road, Tilton,

former location of the basketball court. Regulations does not allow the sale of a property valued over \$500 without going through bidding process. Deputy Mayor Stamp stated that the Town is not interested at this time in entertaining the sale of this recreational property. Deputy Mayor Stamp stated that the town should begin the process of cleaning this property up.

It was moved by Councillor David Smith, seconded by Councillor Tracy Smith, to notify the applicant that this property is a recreational property and is not for sale at this time.

Snow Clearing Request

A letter was tabled from a resident to request snow clearing at their property located on Brazil's Hill. Mayor Brazil stated that this request has been reviewed on numerous occasions by previous councils, it was deemed private land and therefor not the towns responsibility to plow this right of way.

It was moved by Councillor David Smith, seconded by Deputy Mayor Stamp, to refer this request to the Public Works Committee for review and recommendation back to Council.

Dock Lane - Road repairs

A letter was tabled from a resident of Conception Bay Highway requesting Council re-examine the work they completed at Dock Lane. The work completed a few weeks ago has since washed away and the road is still in bad condition. Mayor Brazil stated that when last reviewed this lane was deemed to be private land and the town cannot take responsibility for repairing and maintaining it. The town agreed to fill in the entrance from the road with crush stone but this has since washed away.

Mayor Brazil recommended to have our town workers install an asphalt slope from the road to the driveway to prevent the asphalt from washing away.

It was moved by Deputy Mayor Stamp, seconded by Councillor David Smith, to have the town workers repair the shoulder of Dock Lane with an asphalt slope.
