## <u>Petitions and/or Visiting Groups</u> <u>Mrs. Florence Young - Ryan's Road</u>

Mrs. Florence Young stated that she is here on behalf of residents of Ryan's Road, she stated that she has signatures from all residents. Their concern is about 40 feet of pavement on Ryan's Road. During heavy rain fall and during the winter the water builds up and pools which causes ice build up in the winter. She stated the road is below the drainage system so the water has no where to go. She stated she has brought up this issue many times in the past and would like for Council to repair the problem. Mayor Brazil stated that himself and the Town Manager visited the area this morning and the road is in need of repairs. He stated that during the Fall the town budgets for roads in repair for the following year so this area will be discussed at this meeting. She questioned if while the Department of Highways were onsite repairing the main road could Council contact them and see if the equipment could be used to repair this road as well. Mayor Brazil stated that he would contact our MHA Pam Parsons and see what could be done.
