## 2019 Gas Tax Road Reconstruction and Paving

A meeting to open bids for 2019 Road Resurfacing - Town of Spaniard's Bay convened at 3:00 pm on Friday, August 23, 2019. In attendance were Deputy Mayor Darlene Stamp and Councillor Sherry Lundrigan representing Council and supplier representatives included Kevin Keating of Concord Paving Ltd., Jessica Weir of Weir's Construction and Neil Parsons of Parsons Paving Ltd. .

The work includes pavement resurfacing at Hunt's Road and Peddles Road. Three other roads including Butt's Path, Whalefinn Drive and Finn's Hill require some base work and are to be paved for the first time.

A total of Three (3) bids were received by the 3:00 pm close of bids on Friday, August 23, 2019.

This work was done during a period that although there was a name on the property for municipal records purposes, there were no deeds available to verify property ownership and at one point, was even considered property of the Crown."

The only way that the Town can legally own a property when it is the subject of a tax sale is if it actually bids and becomes the successful bidder at the auction. In this instance, there were no bids received.

It was moved by Deputy Mayor Stamp, seconded by Councillor Tracy Smith, that Council seek legal advise on how to acquire legal ownership of the parcel of property in question as it is currently in limbo. Once ownership has been determined Council then can make a decision on how to dispose of the property if that is the decision of Council at that time.
