A regular meeting of Council took place on the above date with the following members in attendance: Mayor Brazil, Deputy Mayor Stamp, Councillors T Smith, D Smith, Jewer, Ryan and Lundrigan and Town Manager Tony Ryan.

Visitors included Donald Gosse, Dave Gosse, Sheldon and Jackie Coombs, Justin Dyke, Ross Snow and Brenda Coombs. Mayor Brazil called the meeting to order at 7:05 pm and welcomed everyone to the meeting.

Motion to Adopt Agenda

The agenda for the March 9, 2020 meeting was tabled.

Deputy Mayor Stamp asked to have item 6 D added as the Volunteer Dinner & Dance. It was moved by Councillor Jewer, seconded by Councillor Ryan, to adopt the Agenda of March 9, 2020 as amended.

Petitions and/or Visiting Groups

Volunteer Fire Department - Year End Report

Mayor Brazil stated that Justin Dyke was here to answer any questions.

It was moved by Councillor T Smith, seconded by Councillor Jewer, to accept the year end financial report from the Spaniard's Bay Fire Department as presented.

Northern Cove Marina Committee - Year End Report

Mayor Brazil stated that this is the year end report for the Marina Committee, there is no activity on this account only banking fees as they have not began operating.

It was moved by Deputy Mayor Stamp, seconded by Councillor Ryan, to accept the year end financial statement from the Northern Cove Marina Committee.

Mayor Brazil asked if the Liaison could mention to the committee about having some garbage bins in the area. Councillor Ryan stated that he would bring it up to the committee.

Adoption of the Minutes

The minutes of the meeting of February 10, 2020 was tabled.

It was moved by Deputy Mayor Stamp, seconded by Councillor Jewer, that the minutes of the meeting of February 10, 2020 be adopted as presented.

Town Managers Report

A verbal Report was given by Town Manager Tony Ryan.

- 1. To the best of our knowledge there is 2 leaks outstanding. 1 near intersection of Battens Road and Cranes Road and the other is at Back Cove Road South Neither leak is creating an ice hazard currently.
- 2. Work on our OH&S Policy Manual is nearing completion. Michelle Newton has advised that she will deliver the finished product on March 10th. Upon review and pending any required changes, I will be seeking a motion to adopt the new policy at the next regular meeting of Council.
- 3. Tenders for Garbage collection for the next 3 years closed on Friday March 06, 2020 at 3:00 pm. Three companies submitted bids, Lynch's Trucking Enterprises Ltd, Ridge G&P Services and Provincial Ready Mix. The lowest bidder meeting our specs was Lynch's Trucking Enterprises Ltd at \$552,000.00 HST and Tipping Fees included. This equates to \$184,000.00 per year or approximately \$160.00 per household per year. A summary of all bids is attached to my report. I need a motion to award this tender to Lynch's Trucking Enterprises Ltd. As they were the lowest bidder meeting the specifications. For your information there is no need to amend our budget as it falls within what we had budgeted for the year.
- 4. Attached to my report is a copy of the 2019 financial report for the Heritage Society. If Council is agreeable, I need a motion to adopt the 2019 Financial Report for the Heritage Society. If not, I need a motion to defer to the next regular meeting of Council. Also attached to my report is a letter from Heritage society regarding necessary quotes from the Heritage Garden Project and a request for funding assistance both cash and in kind to complete the project. Maybe the Heritage Liaison can speak to this item.
- 5. Attached to my report is a quote from Chris Barret to complete necessary repairs to the Lift Station panel by the gazebo in the amount of \$9156.00. I need a motion of Council to accept this quote so we can proceed with the work. In addition to the price quoted, we will need to hire Afonso's to drain and clear the well in order to install the pump correctly on the rails. Approximate additional Cost \$3000.00.
- 6. Snow clearing equipment is in good working order. The John Deere Loader requires Minor repairs to the wing. This work will be completed over the next couple of days. The 2015 Diesel pickup is scheduled to have work done March 10th at Avalon Ford. The vehicle will be returned to the Town by the end of the day.

Motions arising from the Town Managers Report

It was moved by Councillor Jewer, seconded by Deputy Mayor Stamp, to award this tender to Lynch's Trucking Enterprises Ltd, as they were the lowest bidder meeting the specifications with a bid of \$552,000.00 HST and Tipping Fees included.

It was moved by Deputy Mayor Stam, seconded by Councillor Jewer, to accept the 2019 year end Financial Statement from the Heritage Committee.

It was moved by Deputy Mayor Stamp, seconded by Councillor David Smith, to defer the letter from the Heritage Committee to the next regular meeting of Council to give Council time to review it.

It was moved by Councillor Jewer, seconded by Councillor Ryan, to accept the quote from Chris Barrett Electrical in the amount of \$9156.00 to repair the lift station panel by the gazebo and in addition hire Afonso's to come out to drain and clear the well in order to install the pump correctly on the rails with an approximate additional cost of \$3000.00.

Councillor Ryan questioned how many lift stations have we fixed? Town Manager stated that we have fixed 8 and there are 13 in total. This is normal and is part of regular maintenance to the upkeep of this equipment.

A letter was tabled from the Federation of Canadian Municipalities requesting our town to join their services. Mayor Brazil stated that we receive this request every year and turn it down as we are receiving the same services from Municipalities NL. There is no need for a duplicate service.
