A meeting of Council took place on the above date with the following members in attendance: Mayor Brazil, Deputy Mayor Stamp, Councillors T. Smith, Jewer, D. Smith, Lundrigan, Ryan and Town Manager T. Ryan. Visitors John Churchill, David Rees, Tony Dominic, Bradley Barrett and Gerald Carr. All residents are invited to watch via Spaniard's Bay Facebook page Live. Mayor Brazil called the meeting to order at 7:01 pm and welcomed everyone to the meeting.

Motion to Adopt Agenda

The agenda for the meeting of July 5,2021 was tabled.

Mayor Brazil asked to have item number 5 Town Manager's Report removed.

It was moved by Councillor Jewer, seconded by Councillor Ryan, that the Agenda of July 5,2021 be adopted as amended.

Petitions and/or Visiting Groups.

Councillor D. Smith declared a conflict of interest in accordance with section 207(1)(c) of the Municipalities Act as a close relative lives near the Marina.

He left the meeting 7:05pm.

Mayor Brazil stated that the report was circulated to Council for review.

Mr. John Churchill stated that they made some phone calls and was speaking with Mr. Ken McDonald and stated he was told that anything inside the survey the town owns and we do not need any permits from DFO to move on. A general discussion and question and answer took place regarding the costs of the docks, and the plans of what needed to be done with the docks. Council stated that it is a large sum of money late in the year that is not budgeted for. Deputy Mayor Stamp explained how when Council took the wharf over it was for a load and go purpose. It was agreed that the Committee needed an answer on how to go ahead with their plans. Mayor Brazil explained how this was a large amount of money not budgeted for to put on the expense of the taxpayers, which will only benefit 8 boat owners.

Mayor Brazil stated that our item of illegal dumping will go to the next meeting as they did not get a quorum to go ahead with this meeting.

Heritage Committee- Museum Rood

Mayor Brazil stated that he had someone come in and look at the roof. He stated that there are leaks in the main area and the steeple. Council allotted \$12000.00 in the budget for repairs, so we need to get some quotes to have the repairs completed.

It was moved by Councillor T Smith, Seconded by Councillor Ryan to seek quotes to have the repairs completed at the Museum.

Gas Tax Paving Tender

Town Manager Tony Ryan stated that we had a total of 5 bids. Concord Paving was the lowest bidder to spec at \$191,954.78.

It was moved by Councillor Jewer, Seconded by Councillor Ryan, to award the tender to Concord Paving in the amount of \$191,954.78 HST Included.

Pondside Road

Councillor Jewer stated that Council have become aware of an issue with the culvert on Pondside Road where paving is being completed this year.

It was moved by Councillor Jewer, Seconded by Councillor Ryan, that Council exclude the section of culvert that crosses Pondside Road adjacent to Denny's Road from MCW-21-

00005 for paving and upgrading at Pondside Road and make a separate application under the Capital Works Program next year to install a bridge/culvert system at that location to comply with new flood water standards.

Town Manager Tony Ryan stated that in reference to the upcoming Municipal Election there are four items that Council need to consider and may or may not wish to make changes to. All other items are the responsibility of the Returning Officer and that position is decided by section 13 of the Municipal Elections Act.

It was moved by Councillor Jewer, seconded by Councillor Ryan, to appoint Vanessa Butler as the Alternate Returning Officer for the 2021 Municipal Election.

Mayor Brazil stated that Council have had a meeting with the residents, received petitions, had a public consultation, and received emails and letters from residents.

It was moved by Councillor Jewer, seconded by Councillor Ryan, to get quotes on the cost for two turn arounds for the road.

Carried

A general discussion occurred weighting options of turning the road into a one-way street for the time being until we can get quotes and funding for the two turn arounds. Council discussed pros and cons of both options.

Council took a recess at 8:17 pm Councillor returned at 8:27 pm Meeting resumed at 8:28 pm

Request for Saw Mill – 57 New Harbour Road

Town Manager Tony Ryan stated that the only new information he was presented was that the Town of Carbonear has approved one in their community.

Town Manager Tony Ryan stated that in Classifications of uses of Land and Buildings "Mill" falls under General Industry and the zone that this applicant is in is Residential Medium Density, and General Industry is not listed as a permitted Use or a Discretionary Use.
