Motion to Adopt Agenda

Mr. William Butt

Mr. Butt discussed a water line leak he had at his property. He brough in a rock and a piece of joined pipe which he believes to be the cause of his water line leak along with vibrations of paving equipment this past fall. He explained how costly it was to repair and believes that the break was no fault of his own.

Town Manager's Report

- 1. To the best of our knowledge there are two (2) leaks outstanding. One at Blandford's Road and one at the Battery. In relation to the leak at Blandford's Road, we will first schedule repairs to the valve of the 2 inch water line. Once these repairs are complete we can isolate that section of town without shutting off the water at Bishops Cove Road. We expect to start the valve repair job on Monday, April 10th.
- 2. I need a motion to pay invoices in the amount of 10,229.58 representing invoices received since the agenda cut off on Thursday.

- 3. The Town conducted an Open Call for bids to provide Domestic Garbage Collection and Residential Bulk Collection and Disposal. The Call for Bids closed on March 31, 2023, at 3:00 pm. One bid only was received in the amount of \$220,800.00 per year inclusive of HST and Tipping Fees. This bid will equate to \$18,400.00 per month beginning in May, 2023 for a period of 3 years.
- 4. The recent blockage of ice in the bay has left the piping to the Mint Cove Outfall in disrepair. We will get the chance to view the area sometime in the upcoming weeks. The point of sewer discharge has moved close to shore indicating that there is pipe damage as well as diffusers missing. I also expect that all three diffusers at the Northern Cove Outfall have been destroyed as well. There is no change to the discharge point at the Northern Cove Outfall.
- 5. Attached to my report is an invitation from the Stewardship Association of Municipalities for Town to send a representative to their AGM in Port au Choix May 26 & 27, 2023.
- 6. Attached to my Report are 2 applications to build Storage Lockers. In at Bishop's Cove Road, formerly the Salt Beef Plant and the other just beyond the Seal and Save Building. I would like for the Planning Committee to review these applications.
- 7. The Town's Backhoe has been out of service awaiting repairs to the boom. We have selected another shop to perform the work and expect it will be finished by Thursday.
